APPLICATION FOR SERVICE - HIBBING PUBLIC UTILITIES

The Undersigned responsible person(s) hereby make application to the Hibbing Public Utilities Commission of the City of Hibbing for the supply of Electricity, Water, Gas and Steam, for use upon the premises for the Service Address provided. Customers who pay deposits earn annual interest on the deposit money which is credited to the account yearly in January. This deposit is kept for 2 years of good credit and will be applied to the final bill when moving out. Upon termination of a utility account, the customer must provide 24 hours notice and access to the meters on the service property. If access is not provided, billing will continue in customers name until further notice. Consumption shall be measured by meters installed by said Hibbing Public Utilities Commission, and hereby agrees to use said electricity, water, gas, steam meters strictly in accordance with the rules and regulations of said Public Utilities Commission, which rules and regulations are as truly a part of this application as though printed hereon in full.
